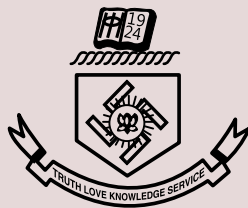

In its 96th year now, the College is in the “Countdown 100 Years” mode. We have grand plans spread over the next few years as we set our sights on celebrating the Centennial. The College has made huge strides in both Academics and Infrastructure in this decade. It introduced two new Honours programs in Geography and Sociology and has six vibrant Research and Learning Centres: the Museum and Archives Learning Resource Centre, the Translation and Translation Studies Centre, the Centre for Earth Studies, the Centre for Interdisciplinary Studies, the Sanskrit Studies and Research Centre and a unique Music Archives and Listening Room. In Delhi, families that have traditionally educated women, have passed the portals of this College, as the pioneering institution of higher education for women. Our swimming pool built in 1956, when it was unthinkable for our girls to swim in public institutions, has celebrated its 60th year. The almost 65 year old Kalavati Gupta Hostel on the College campus has been redesigned, renovated and refurbished, and the Indraprastha College Women's Hostel has been renovated with the option of AC rooms.

The College with its infrastructure and facilities is at your disposal to help you grow and develop, to enable yourselves and become independent and confident young women who can take on the world on their terms. Its accomplished faculty and friendly support staff will encourage you to claim the College as your special world, one that you will treasure and carry with you always. IP College is about you! History & Heritage

The Indraprastha College for Women was founded in 1924 and is the oldest women's college of the University of Delhi. It began with three students, in a room on the second floor of an old, now heritage, mansion housing the Indraprastha Girls' Senior Secondary School, in Chhippiwara in the Jama Masjid area of Chandni Chowk, in the walled city of Old Delhi. Degree courses were introduced in 1930s, and the University recognized Indraprastha College as a degree college in 1938. After some years, the College moved to Chandrawali Bhawan in the Civil Lines, and was moved again to 'Alipore House' at Alipur Road (now Sham Nath Marg) to the office-cum-residence of the British Commander-in-Chief in 1938, where it exists till today.

The parent school and the College both grew out of the efforts of a group of philanthropists associated with the Theosophical Society of India. They were inspired by Mrs. Annie Besant, also a theosophist, who believed in and promoted education for women in North India, at a time when women were confined to home and realized their destiny in marriage and motherhood. The vision of the College intensified over the decades, and remains focused on the holistic development and empowerment of women.

The College has intersected the National Movement, the Education Reforms Movement, and the Women's Movement, and is itself a movement today. It has a glorious tradition of academics and service which has only grown over the years. Housed in a beautiful building, on a green campus spread over 14.5 acres, the College building was accorded heritage status in 2002. The College is a milestone in the heritage walk of colonial Delhi. As the College marches towards its centenary, it has added to its academic and infrastructural resources, always mindful of its core vision to empower and mainstream the marginalized.

Vision

The Vision of the College is to educate, enable and empower young women, emphasizing the need to mainstream the marginalized and weaker sections among them, to ensure justice and equity in society.

Mission

The Mission is to steer the education it offers not only to lead to the pragmatic goal of employability, but also to build a life of the mind and sensitize and orient its students to service of the community, in the quest for a better life for society and the world that we inhabit. The College endeavors to nurture confident and responsible citizens who will uphold the values enshrined in the motto of the College 'Truth, Love, Knowledge, Service'. To this end the College's mission statement is set out as definite tasks which define the College's distinctive characteristics in terms of addressing the students it seeks to serve, the institution's traditions and value orientations, the needs of society and its course for the future. The Mission is dynamic and its tasks are defined and periodically reviewed to meet the challenges and opportunities of changing times.

Objectives

The Objectives of the College are stated in the tasks of the Mission. The College seeks to inculcate through its programs :

- belief in self as a woman (through enabling strategies and empowerment as women)
- awareness of history, heritage and environment (through its own location within these and its links with global concerns and issues)
- respect and sensitivity for the 'other' (by exposure to culture diversity, languages, human rights)
- values of citizenship (civic sense, public conduct, leadership, rights and responsibilities)
- encourage and build scientific temperament and rational thinking (through inter-disciplinary theme in activities and research)
- development of presentation and writing skills (by incentives for research and innovation)
- enhancement of employability and life-skills (by organizing hands-on training and workshops)
- holistic development through curricular and co-curricular activities (through mandatory membership and participation in a minimum of two co-curricular activities) in the College.



ABOUT INDRAPRASTHA COLLEGE FOR WOMEN

Indraprastha College for Women (estd. 1924) is a constituent college of the University of Delhi and its oldest women's college. Founded as a part of a nation-wide campaign for women's education and empowerment, it is located on a beautiful campus which is a recognized heritage site and a landmark of Delhi. It has an enrolment of approximately 3500 students in its UG and PG programs. The College offers a wide range of courses, which promotes interdisciplinary studies in the 3 streams of Humanities, Mathematical Sciences and Commerce. Uniquely, the College offers the Self-Financed BA (Hons) in Multi Media and Mass Communication.

The College Student Services include a vigorous Diversity Integration Program. The College has a 'Need-blind Admission Policy' and offers need-based financial assistance to new entrants at the time of admission itself. The College is 100% barrier free and has a 'Under One Roof' Enabling Unit (EU) and Equal Opportunity Cell (EOC). Apart from a proactive financial aid policy, it organizes courses in English and ICT skills for the EWS and PwD-oriented skill training courses. The College publishes its Annual Report and Prospectus in Hindi and its website in Hindi is active at hindi.ipcollege.ac.in.

For advanced learners, the College has a Research Methodology Program. The College has instituted an UG Research Grant for innovative and original projects. It has an International Students' Desk, North East Society and an active Women Development Cell with a Gender Sensitization Cell. It offers basic medical facilities with regular attendance of a Nurse and a Counsellor, with the neighborhood hospital for medical emergencies. The College has a mentorship program and a Career Guidance and Placement Cell.

The College has created six Research and Learning Resource Centres. The Museum and Archives Learning Resource Centre houses heritage and contemporary exhibits of the College. The Translation and Translation Studies Centre is aimed at independent research and skill development in languages. The Centre for Earth Studies promotes research in ecology and environment for sustainable development. The Centre for Interdisciplinary Studies brings all the disciplines of the College together. The Centre for Sanskrit Studies and Research and the Music Archives & Listening Room (MALR) are the latest addition.

The College has two hostels to accommodate 450 students, the 170 seater Indraprastha College Women's Hostel and the Kalavati Gupta Hostel (KG) which has a total number of 280 seats. The IP Hostel has been renovated with the option of AC rooms.

The well-stocked Library has a book bank, a lift for disability access and an ICT centre with 80 computers. The College has its own Studio and Production Centre with independent editing facilities, a hub for Community Radio with world-wide broadcast facilities through DUCR, an Audio-Visual Resource Centre, Seminar rooms, state-of-the-art Conference rooms, a fully air-conditioned Auditorium with 586 seating capacity, four Exhibition Foyers, well-equipped laboratories and other infrastructure to support its academic and co-curricular activities. It has vast playgrounds and multi-facility sports infrastructure with a Swimming Pool, Climbing Wall, Walking Track, Gymnasium, Shooting Range, Fitness Centre and a sprawling sports complex. A wide range of extra-curricular activities are encouraged. The College has its own 26 seater bus. To support its formidable infrastructure and facilities, the College has full power back-up to ensure that all activities are carried out without interruption.

The College has an active Internal Quality Assurance Cell (IQAC) and submits its Annual Quality Assurance Report (AQAR), regularly to the accreditation body.

Indraprastha College for Women admits students to all the three streams: Arts, Commerce and Mathematical Sciences which are taught in the semester mode under Choice Based Credit System (CBCS).

Supernumerary Seats

- 5% of the total number of seats are reserved for Persons with Disabilities (PwD)
- 3% of the total number of seats are reserved for candidates admitted under Sports Quota
- 5% of the total number of seats are reserved for Foreign Students
- 5% of the seats in each course are reserved for Children/ Widows of the eligible Armed Forces Personnel (CW Categories)
- A total number of 10 seats are reserved for Prime Minister's Special Scholarship Scheme for Jammu & Kashmir Students (PMSSS). The applicant selected under PMSSS will be admitted to the College directly.
- Ward Quota: For admission of the wards (daughters) of the employees of the University/other colleges (teaching/non-teaching) the total number of seats for admission will not exceed six (three for the teaching and three for the non-teaching employees) on the basis of merit and subject to fulfillment of minimum eligibility conditions. The schedule and process for admission under Ward Quota will be notified on the University website.

Post Graduate Courses: Total Seats: 254

Students are enrolled in the College for the following Post Graduate courses after admission in the concerned Faculty of the University of Delhi. The University of Delhi allots seats for each of the courses mentioned below.

English, Hindi, History, Mathematics, Music, Operational Research, Philosophy, Political Science, Psychology and Sanskrit.

Criteria to choose Compulsory Language Courses

English A

- Those who have studied Hindi up to class XII will do Hindi-A as a Compulsory Language Course in Hindi

Hindi B

- Those who have studied and passed Hindi up to class X/VIII will do Hindi-B as a Compulsory Language Course in Hindi

Sanskrit

- Those who have studied Sanskrit till class VIII can opt for Sanskrit as a Compulsory Language Course in lieu of Compulsory Language Course in Hindi

Multi Media and Mass Communication (Self-financed)



Indraprastha College for Women is the only College of the University of Delhi and the country, to offer B.A. (Hons.) Multi Media and Mass Communication. The Course is self- financed and approved by the University of Delhi. The Course is located within the Faculty of Applied Social Sciences and the Humanities (FAASH) and is based on the basic principles of Social Sciences and Humanities and their interdisciplinary nature. It is also an application course which imparts technical knowledge, skills and hands-on training in the use of the latest technology.

The objective of the Course is to create a practitioner with a critical and analytical mind, who is holistically trained in theory and the praxis of communication and is able to apply these to a wide range of media technology and media practices. The Course emphasizes not merely on producing skilled workers for the media industry, but also on developing a core competence and comprehension of communication across mass-media, in their complexity, political dynamics, technological advances and transformations.

The Course seeks to extend employability of students beyond the spectrum of the media industry, to public policy, production and higher and specialized education.



An essential component of the course is a 4-week internship in a related agency. Some of the thrust areas of the Course are also those fore-grounded on the national agenda, and the College is keen to avail the outreach policies and programs of the Government of India in the areas of knowledge application and skill development.

IP College has the infrastructural wherewithal to make the required facilities available to run the Course. The department has a state-of-the-art Audio-Visual Resource Centre. There is a fully equipped studio, a radio production centre, editing bays, updated softwares and applications, and the equipment required for in-house training and production related to the Course.

The Course is taught by faculty drawn from related departments of the College and other institutions, and experts and practitioners from the media industry. In 2019, the Department is celebrating 20 years of its existence. Admission is through an All India Entrance Test, conducted by the University of Delhi.

Research and Learning Centres

Museum and Archives Learning Resource Centre



The College Archives was expanded into a museum and archives learning resource centre and relocated in a modern display gallery in 2015. Currently, the Archives cover the period 1924-2006. The expansion of the Archives and showcasing the College for the period 2006-2018 was initiated in November 2018 in collaboration with Heritage Associates, New Delhi. The major parts of its holdings have been donated by the late Chairman, Governing Body, Shri Narain Prasad. The pictures have been restored and digitized to be available for visitors to see and for study by interested scholars. The Centre is part of the prestigious Sahapedia, an

open online resource on the arts, cultures and heritage of India. The Centre is in collaboration with scholars of University of Technology, Sydney on a Project on Ms. Leonara G'meiner, an Australian theosophist and the first Principal of the College. The Centre is committed to bringing out an annual heritage calendar culminating in the College's centenary year. The Centre and the College, a heritage site, is recognized by the Government of NCT of Delhi and is a popular stop for the Delhi Heritage Walk.

Translation and Translation Studies Centre

The Translation and Translation Studies Centre was set up in 2015. Translation as an activity is promoted by the College to stimulate student interest and engagement with both language and cultural diversity, particularly in India. The College identified translation and translation studies in India as an emerging area which requires academic engagement and keen scholarship. It views translation as an area with potential also for skill development and employability, apart from enhancing language skills for various kinds of academic tasks and research. The Centre's activity aims at giving impetus to research and independent learning. It has successfully cut



across departments to evoke wide ranging student participation. The student journal of translation - 'CODE' is produced annually by the Centre. The Centre organizes lively activities around language throughout the year. Scholars and practitioners are invited to deliver talks at the Centre. A certificate course on 'Editing and Publishing' (Bilingual) is also offered by the Centre, which is very popular with students. In 2018, the College was awarded a collaborative Translation Project by Sahitya Akademi, under which a three day long Translation Workshop was held to translate 15 short stories from Hindi to English under the Project Director, Principal Dr. Babli Moitra Saraf and Coordinators Dr. Vinita Sinha and Dr. Rekha Sethi. The unique feature of this task was the involvement of student translators and their teacher mentors, who enthusiastically participated to complete the project. The anthology is due for publication.

Centre for Earth Studies

The Centre for Earth Studies was launched in 2016 with a vision to promote research and learning in areas around sustainable development. It aims to develop life skill, environmental awareness and ecological consciousness among the community that will be ready to face challenges of climate change, environmental degradation and ecological conservation. In this journey towards a common sustainable future, the Centre takes up several research projects for students to work under expert faculty mentorship. It has successfully carried out a



tree census of the campus in 2017 followed by a bird diversity census in 2018. The latest project conducted in 2019 was on the dust capturing capacity of the existing green belt of the campus which may have major policy implications for addressing the severe air pollution problem of Delhi. The Centre works towards the creation of a waste-neutral campus by running a comprehensive waste management program including plastic and e waste collection for scientific disposal, waste paper collection for recycling, leaf composting and kitchen waste management. Seminars, talks and workshops are organised regularly as a part of the green capacity building initiatives. Other activities include bird watching, wild life rescue, earth tourism and field trips in order to instil a holistic awareness for green living in a sustainable planet.

Centre for Interdisciplinary Studies



Established in 2016, the Centre for Interdisciplinary Studies, encourages students to undertake research and projects which enable the creative interplay of academic disciplines in the belief that this enables greater depth and complexity in the analysis of social realities. Through its activities the Centre promotes familiarity with the methodologies of specific disciplines by encouraging their critical application to chosen subjects of study by students. It has also organized seminars, conferences and talks by scholars. The Centre began with a two part seminar series, *Dilli. Perspectives on Delhi* that explored themes related to oral and architectural heritage, equitable access to civic

resources; the tragedy of the city's commons and ethnographic explorations of urban spaces. With *Dilli: City of Opportunity : Women and Work in Delhi* relevant aspects of women's work were discussed by women cab drivers, psychologists, sociologists and college students. The Centre also coordinated an outreach research project 'HUM SAB' with migrant labour on College campus. Subsequently a semester-long student research project on *Cinema and Society: Intersections of Caste and Gender*, culminated in 16 student research presentations. More recently a seven-part student seminar series focussed on discussions and presentations around selected readings and documentaries on the theme *The Great Reservation Debate: Society and Politics in India*, which 18 students completed successfully. A series of talks on *New Forms of Violence Against Women* has also been initiated and will carry over into the next term. The Centre's activities have seen very enthusiastic response from students from across departments of the College.

Music Archives and Listening Room (MALR)

The Music Archive and Listening Room is a unique project initiated in 2017, which encourages the pursuit of “listening” to music and discovering its making in all its nuances. The Archive is a collection developed through donations from music lovers and practitioners of Hindustani Classical Music in its myriad forms. The activities of the Archive are organized with the active participation of students who have formed a society called *Baithak*. The activities of MALR range from conducting movie screenings on the lives of stalwarts of Hindustani Music to organizing performances and lecture demonstrations by renowned artists; conducting informal listening sessions for the college community and cataloging of the rare recordings done by students under the supervision of faculty advisors.

Sanskrit Studies and Research Centre

The Sanskrit Studies and Research Centre was inaugurated on 20 September 2018 and is envisioned to promote the study of the Sanskrit language as an invaluable heritage which is a key to unlock the vast corpus of knowledge it treasures. It proposes to focus on the interface of Sanskrit with other disciplines like Linguistics, History, Literature, Philosophy, Mathematics and so on. It is an off-shoot of the Translation and Translations Studies Centre and rests upon the College's collection of rare books in Sanskrit. The Centre proposes to promote the acquisition of language skills along with the phonetics and phonology of Sanskrit. It will encourage translation from Sanskrit into other Indian and foreign languages. It will network with all the Learning and Resource Centres of the College in activities that have the possibility to highlight the contribution of Sanskrit language and writings in it. It will explore collaboration with like-minded academic and cultural bodies to establish linkages to carry the Centre forward. A ten-day Certificate Course in Spoken Sanskrit was conducted in 2018.

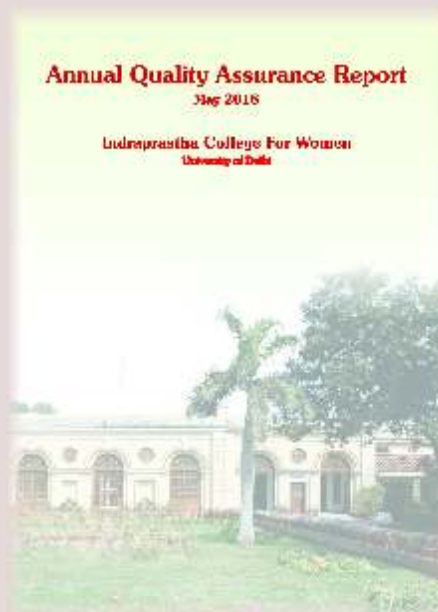

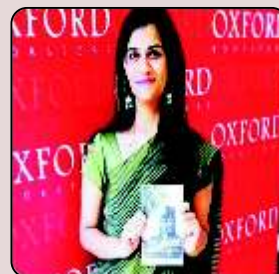

Fee Refund Policy

Rules for Refund of Fee on Account of Withdrawal/Cancellation of Admission will be superceded by the directives of the University of Delhi, if any.

5.	In case a student after his/her admission expires within one month of the last date of admission.	Full fee including examination fee will be refunded to his/ her parents.

A maximum of two language subjects may be allowed for the calculation of marks for 'Best Four' combination.

In case an applicant has studied Elective and Core languages, the Core/Elective language subject will be treated as language, while Elective language can be considered as academic / elective subject.

For the calculation of "Best Four" subjects percentage for honours courses where required, if the applicant includes subjects other than those given in Lists A and B, then a deduction of 2.5% of maximum marks will be levied for each such subject for the purpose of calculating 'Best Four'.

The applicants shall be required to produce following documents in original with two sets of self-attested photocopies at the time of admission:

1. Class X Board Examination Certificate/Mark-sheet indicating date of birth.
2. Class XII Mark-Sheet
3. SC/ST/OBC/EWS/PwD/CW/KM Certificate (in the name of the Applicant) issued by the competent authority.
4. OBC (Non-Creamy Layer) Certificate (in the name of the Applicant) issued by the competent authority as in the central list <http://ncbc.nic.in>.

The validity of the Non-Creamy Layer Certificate shall be for the financial year 2018-19, issued on or after 31st March, 2019.

5. EWS Certificate from competent authority certifying the applicant can claim reservation under this category dated March 31, 2019 or later.
6. Two passport size self-attested photographs.

Note:

1. **The name of the applicant claiming reservation under SC/ST/OBC/EWS/PwD/CW/KM as it appears on the reservation certificate must match with her corresponding school board qualifying certificate.**
2. **The names of the parents of the applicant claiming reservation under SC/ST/OBC/EWS/PwD/CW/KM must match in both sets of certificates.**
3. **Students are hereby informed that if any false attestation/falsified records are detected, then the students will be debarred from attending any course in the University or its Colleges for next five years. In addition, a criminal case u/s of IPC (viz. 470, 471, 474 etc.) will be instituted against her.**

Hostel Admission

The College has two hostels namely, Kalavati Gupta Hostel (KG Hostel), on its campus, and the Indraprastha College Women's Hostel (IP Hostel), across the road opposite the College with a total number of 450 seats. A limited number of seats is available for new entrants this year. Students have to apply separately for Hostel accommodation. The student will be eligible for Hostel admission only after she is admitted to a course in the College. Admission is strictly on the basis of merit. For further information on both the hostels, please visit the College website. The Hostel Prospectus containing all related information is also available.

Orientation Program

It is mandatory for the new entrants to attend the Orientation Program on 20th July, 2019 at 10:00 a.m. in the College Auditorium. The access to the live Orientation Program is also provided in the College Conference Hall, Seminar Room and Audio-Visual Room. **Only candidates will be seated in the Auditorium. Accompanying parents/guardians are to be seated in other designated spaces.**

College Orientation will be followed by an Orientation of the students in the respective departments, where the students will be familiarized with the academic requirements of their course of study.

There will be an interaction with Parents/ Guardian and the Principal and College Administration, in the Auditorium after the Orientation Program.

Students are requested to read the Notice Board for all directions regarding the Orientation Program.

Guidelines and Procedure

1. 3% of the total number of sanctioned seats are reserved for admission to various undergraduate courses under Sports Quota.
2. The admission schedule for admission under Sports categories will be announced on the centralized admission Web Portal after the registration process is completed.
3. Original Sports Certificates, self-attested photocopy of Sports Certificates and a self-attested photograph of the candidate is required at the time of admission in the college.
4. The candidate submitting false/fake certificate will be debarred from admission to any course in any College for three years. If she is admitted on false/fake certificates, her admission will be cancelled and such cases will be notified to all the Colleges.
5. The candidate has to submit an undertaking on non-judicial stamp paper of Rs.100 stating that she will play for the College and University during her undergraduate course of study.

Note : The candidate is required to check Delhi University Sports Council (DUSC) and University of Delhi website for dates, venues and directives etc. regarding sports trials, marking of certificates and other information.

Financial Assistance to Students

- The College has a policy to give financial assistance to students belonging to the economically weaker sections. The call for applications will be in July, as soon as the College reopens. Interested students are required to apply in the prescribed proforma by the specified deadline, with all supporting documents
- The College also awards scholarships on the basis of Merit-cum-means to deserving students.
- There is a Book Bank facility in the library for the students who need to borrow textbooks for the whole semester.
- As per the guidelines of the University of Delhi, the eligible SC/ ST/ OBC and PwD students should submit their scholarship form for processing scholarships to them each year. Further information regarding scholarships/financial aid/ stipends will be displayed on the College Website and College Notice Board.

Note: Scholarship / fee waiver / financial aid from the College will continue to be extended only to those students who fulfill attendance, internal assessment and other course requirements.

Rules and Regulations

Attendance Requirement and Rules for all enrolled Students

The College firmly believes in the classroom interaction and experience and insists that regularity in class is necessary for students to derive value from a semester programme.

1. Regularity in the class/ class presentations/tutorials/practicals is compulsory every semester, and forms a part of the evaluation for Internal Assessment.
2. Attendance of students is compulsory in all activities of the Departments including Seminars/ Conferences/ Talks etc. that are organized during the year.
3. Students are strictly advised against joining any other programme of study/ internship/employment/ activity during the academic session when classes are engaged.
4. It is essential for students to have a minimum attendance of 2/3rd of the total number of classes separately in Lectures and Practicals in every semester.
5. Submission of projects and meeting deadlines for assignments etc. is compulsory. Students not submitting in time will be penalized in the evaluation.
6. Students with less than 2/3rd attendance and absence in the Student Presentation session of Departmental Academic Society, will not be facilitated by the College for hostel admission, financial assistance, official positions, prizes, recommendations, internships etc.
7. A student who does not fulfill the minimum attendance requirement per semester, will be considered to have wasted the precious resources of the College and will forfeit all refundable deposits made to the College and will pay under that head in the successive semester at the time of payment of fees.
8. The College reserves the right to debar students falling short of the required attendance, from taking class tests related to Internal Assessment and non-acceptance of assignment related to the same.
9. Students who do not pay their fees to enrol in the Semester by 16th August 2019, will not be permitted to fill the Examination Form and will be deemed to be not on the rolls of the College.
10. Students who do not fill the Examination Form in time, will not be permitted to submit them after the announced deadline.
11. An ex-student can take the examination only if she has requisite attendance, as per University rules. The Internal Assessment marks will remain unchanged.

Note: Students are directed to check the College website regularly for information and updates.

Attendance Waivers for Representing College/University/Country

Students officially representing the College in any activity are required to seek prior sanction and submit related documents duly verified by Advisors/Competent Authorities within three days of their return, to avail waiver on attendance.

Submission of Medical Certificates

Medical certificates should be submitted within 3 days of joining back with a covering application addressed to the Principal along with supporting documents (lab reports, X-ray etc) at the college dispatch window. A copy of the medical documents submitted to the office has to be given to the teacher-in-charge for record. No medical certificate will be accepted later.

Submission of Examination Forms

Students are required to submit their examination forms in time as per the announced schedule. Students who fail to pay their College fees for the academic session by the due date will not be permitted to fill the examination form.

College Discipline-Ordinance XV-B

1. All powers relating to discipline and disciplinary action are vested in the Vice-Chancellor.
2. The Vice-Chancellor may delegate all or such power as he/she deems proper to the Proctor and to such other persons as he/she may specify in this behalf.
3. Without prejudice to the generality of power to enforce discipline under the Ordinance the following shall amount to acts of gross indiscipline:
 - a. Physical assault, or threat to use physical force, against any member of the teaching and non-teaching staff of any Institution / Department and against any student within the University of Delhi.
 - b. Carrying of, use of or threat to use of any weapons.
 - c. Any violation of the provisions of the Civil Rights Protection Act, 1976.
 - d. Violation of the status, dignity and honour of students belonging to the scheduled castes and tribes.
 - e. Any practice-whether verbal or otherwise- derogatory of women.
 - f. Any attempt at bribing or corruption in any manner.
 - g. Willful destruction of institutional property.
 - h. Creating ill-will or intolerance on religious or communal grounds.
 - i. Causing disruption in any manner of the academic functioning of the University system.
 - j. Prohibition of Ragging as per Ordinance XV-C.
4. Without prejudice to the generality of his/her powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/her appropriate, the Vice-Chancellor, may in the exercise of his/her powers aforesaid order or direct that any student or students—
 - a. be expelled
 - b. be, for a stated period rusticated; or
 - c. be not for a stated period, admitted to a course or courses of study in a College, Department or Institution of the University; or
 - d. be fined with a sum of rupees that may be specified; or
 - e. be debarred from taking a University or College or Departmental Examination or Examinations for one or more years; or
 - f. that the result of the student or students concerned in the Examination or Examinations in which she or they have appeared be cancelled.
5. The Principals of the Colleges, Heads of the Halls, Dean of Faculties, Heads of Teaching Departments in the University, the Principal, School of Open Learning and Librarians shall have the authority to exercise all such disciplinary powers over students in their respective Colleges, Institutions, Faculties and Teaching Departments in the University as may be necessary for the proper conduct of the Institutions, Halls and teaching in the concerned Departments, They may exercise their authority through, or delegate authority to such of the teachers in their Colleges, Institutions or Departments as they may specify for these purposes.
6. Without prejudice to the powers of the Vice-chancellor and the Proctor as aforesaid, detailed rules of discipline and proper conduct shall be framed.

These rules may be supplemented, where necessary, by the Principals of Colleges, Heads of Halls, Deans of Faculties and Heads of Teaching Departments in this University. Each student shall be expected to provide himself/herself with a copy of these rules.

At the time of admission, every student shall be required to sign a declaration that on admission she submits herself to the disciplinary jurisdiction of the Vice-Chancellor and several authorities of the University who may be vested with the authority to exercise discipline under the Acts, the Statutes, the Ordinances and the rules that have been framed therein by the University.

Prohibition and Punishment for Ragging-Ordinance XV-C

1. Ragging in any form is strictly prohibited, within the premises of the College/Department or Institution and any part of the Delhi University system as well as on public transport.
2. Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under this Ordinance.
3. Ragging for the purposes of this Ordinance, ordinarily means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students, and includes individual or collective acts or practices which—
 - a. involve physical assault or threat to use of physical force.
 - b. violate the status, dignity and honour of women students.
 - c. violate the status, dignity and honour of students belonging to the scheduled castes and tribes.
 - d. expose students to ridicule and contempt and affect their self esteem.
 - e. entail verbal abuse and aggression, indecent gestures and obscene behaviour.
4. The Principal of a College, the Head of the Department or an Institution, the authorities of College, University Hostel or Halls of Residence shall take immediate action on any information of the occurrence of ragging.
5. Notwithstanding anything in Clause (4) above, the Proctor may also suomoto enquire into any incident of ragging and make a report to the Vice-Chancellor of the identity of those who have engaged in ragging and the nature of the incident.
6. The Proctor may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident.
7. If the Principal of a College or Head of the Department or Institution or the Proctor is satisfied that for some reason, to be recorded in writing, it is not reasonably practical to hold such an enquiry, he/she may so advise the Vice-Chancellor accordingly.
8. When the Vice-Chancellor is satisfied that it is not expedient to hold such an enquiry, his/her decision shall be final.
9. On the receipt of a report under Clause (5) or (6) or a determination by the relevant authority under Clause (7) disclosing the occurrence of ragging incidents described in Clause 3 (a), (b) and (c), the Vice-Chancellor shall direct or order rustication of a student or students for a specific number of years.
10. The Vice-Chancellor may in other cases of ragging order or direct that any student or student be expelled or be not for a stated period, admitted to a course of study in a college, departmental examination for one or more years or that the results of the student or students concerned in the examination or examinations in which they appeared be cancelled.
11. For the purpose of this Ordinance, abetment to ragging whether by way of any act, practice or incitement of ragging will also amount to ragging.

सन् १९११ में ब्रिटिश साम्राज्य की राजधानी दिल्ली में स्थानान्तरित होने के बाद अलीपुर हाउस के नाम से प्रसिद्ध यह भवन ब्रिटिश कमान्डर इन चीफ और उनके सैनिकों का आवास बना। इन्द्रप्रस्थ महाविद्यालय का जन्म १९०४ में स्थापित इन्द्रप्रस्थ विद्यालय में हुआ जो जामा मस्जिद के निकट है। सन् १९२४ में यहाँ इन्द्रप्रस्थ गर्ल्स कॉलेज की स्थापना हुई जिसे १९३८ में वर्तमान स्थान पर स्थानान्तरित कर दिया गया।

The building of Indraprastha College, Alipur House, housed the office of the British Commander-in-Chief and his staff after 1911, when the Imperial Capital shifted to Delhi. The College has its origin in Indraprastha school, established near Jama Masjid in 1904. It became a college in 1924, named as Indraprastha Girls College and moved to this building in 1938.
