Contract can be terminated by the college immediately if the conduct of the Service Provider or any of his/her employee(s) is found to be detrimental to the safety of the property, students and employees of the college or any such other action by the Service Provider or any of his/her employee(s) which the College Authorities may deem fit, to be given in writing, for termination of the Contract.
- 7. Service Provider will have to submit Performance Guarantee equivalent to 10 per cent of the quoted amount for the full year and will be released after satisfactory expiry of the AMC period.
